WATER RATES

Inside City Limits: Effective 1/1/2017 basic water availability charge per resident is \$15.24 per month for 5/8" meter. Visit City website for rates of larger meters. Water meters are read for consumption every other month.

Outside City Limits: Water charges are billed every other month. Basic water availability charge per residence is \$23.52 per month for 5/8" meter; call for rates of larger meters.

SEWER RATES

Basic sewer availability charge per resident is \$57.88 per month. Volumetric rate is billed every other month based on the consumption billed for water. Volumetric rates in addition to the availability charge are:

SINGLE FAMILY RATES

Volumetric rate of \$3.60 per 100 cubic feet of water used per month with a cap of 1,000 cubic feet per month.

MULTI-FAMILY RATES

Volumetric rate of \$3.60 per 100 cubic feet of water used per month with a cap of 800 cubic feet per unit per month.

NON-RESIDENTIAL RATES

Volumetric rate of \$3.60 per 100 cubic feet of water used per month with no cap.

Water (utility) charges are due upon receipt and become delinquent on the 15th day of the month following the billing. Disconnection is scheduled 30 days after date of delinquency. Account balance in full plus the turn-on fee of \$100.00 before 4pm Mon- Fri must be paid to reconnect service. After 4pm or weekends the turn-on fee is \$150.00.

SENIOR CITIZEN DISCOUNT

A senior citizen discount is available for qualifying residents. The senior citizen discount is 50% reduction from the water availability charge and 20% reduction from the sewer availability charger per month. Please contact the Utility Department for further information on qualifying requirements at 253-447-4317.

WATER INFORMATION

City water is supplied by natural springs and wells and is chlorinated. City water is not treated with Fluoride. Samples are taken weekly at various locations to guarantee water quality.

LEAKS

Repair of leaks in private service lines are the responsibility of the property owner. After a leak is repaired a written request can be submitted (including receipts of repairs) to the Utility Department indicating the date of the leak repair and a possible adjustment may be issued up to



2/3 of overage usage for a 120 day period. This process may take up to 90 days to complete.

Water (utility) accounts remain the responsibility of the property owner. The owner is responsible for payment even if the property owner provides a written request to bill the tenant. Account transfer to NEW OWNER or TURN ON/OFF of service can be done only by the owner (buyer or seller) of the subject property. Because utility service is a lien against the property purchasers are encouraged to ask their title company to verify billing status prior to closing on a real estate transaction.

GENERAL INFORMATION

Bonney Lake was incorporated as a city in 1949 with a population of 327. The population today is approximately 20,000. Bonney Lake is currently organized as a non-charter code city, under the mayor-council form of government. The City of Bonney Lake is led by a publicly elected Mayor and a seven member City Council. BUILDING PERMITS

BUSINESS LICENSES

Businesses are required to obtain a Bonney Lake business license if they have an office, PO BOX, or place of business located within City limits, as well as liquidators. There are exemptions for non-profits, paper carriers, and others as outlined in BLMC 5.08.050. Apply online at business.wa.gov/BLS. Call 253-447-4354 for information.

SECURITY ALARM PERMITS

Every security alarm user inside city limits must obtain an alarm permit at the Utility Department, Justice & Municipal Center, 9002 Main Street East, Suite 250. Alarm permits are valid for one (1) year, and must be renewed annually. Registration and renewal fees for residential/commercial alarms is \$24 annually, or a Senior (65 or older) or Disabled discount rate of \$12 annually. There is a \$100 per false burglary alarm, and \$200 per false robbery-panic alarm fee per BLMC Chapter 8.48. The Alarm Program Application may also be found online @ www.ci.bonney-lake.wa.us.
