WATER RATES

Inside City Limits: Effective 1/1/2019 basic water availability charge per resident is \$18.56 per month for 5/8" meter. Visit City website for rates of larger meters. Water meters are read for consumption every other month.

Outside City Limits: Water charges are billed every other month. Basic water availability charge per residence is \$28.65 per month for 5/8" meter; call for rates of larger meters.

SEWER RATES

Basic sewer availability charge per resident is \$72.32 per month. Volumetric rate is billed every other month based on the consumption billed for water. Volumetric rates in addition to the availability charge are:

SINGLE FAMILY RATES

Volumetric rate of \$4.50 per 100 cubic feet of water used per month with a cap of 1,000 cubic feet per month.

MULTI-FAMILY RATES:

Volumetric rate of \$4.50 per 100 cubic feet of water used per month with a cap of 800 cubic feet per unit per month.

NON-RESIDENTIAL RATES

Volumetric rate of \$4.50 per 100 cubic feet of water used per month with no cap.

In Person: Cash, check and credit card payments may be made at the Utility desk at the Justice & Municipal Center, 9002 Main St E, Suite 250, Bonney Lake, WA. A night deposit box is located outside for after-hour payments.

By Phone: Call 253-447-4317 during normal office hours.

Utility charges are due on receipt and become delinquent on the 15th of the month following billing. A penalty is added to all delinquencies. Disconnection is scheduled 30 days after the date of delinquency. In the event of disconnection (water shut-off) due to delinquency, all charges plus a \$100.00 turn-on fee must be paid to re-connect service.

Utility accounts remain the responsibility of the property owner. The owner is responsible for payment even if the property owner provides a written request to bill the tenant. Account transfers to a new owner or to turn service on/off can be done only by the owner (buyer or seller) of the subject property. Because utility service is a lien against the property, purchasers are encouraged to ask their title company to verify billing status prior to closing on a real estate transaction.

SENIOR CITIZEN/DISABLED DISCOUNT

A discount on water and sewer charges is available for qualifying property owners who receive the Senior Citizens & Disabled Persons tax exemption from Pierce County. Contact Utilities for details at 253-447-4317.

LEAKS

Repair of leaks in private service lines are the responsibility of the property owner. The City of Bonney Lake offers a leak adjustment to customers who have had a leak in their private plumbing system when the leak is repaired. The adjustment shall be two-thirds of that portion of the customer's water bill which is over the average normal water usage. An adjustment may be granted upon written request with documentation (repair receipts) and approximate date of prompt repair.



WATER SOURCES/WATER QUALITY

City water is supplied by natural springs and wells and is chlorinated. City water is not treated with Fluoride. Samples are taken at various locations to guarantee water quality. Water Quality Reports are published annually.

GENERAL INFORMATION

Bonney Lake was incorporated as a city in 1949 with a population of 327; today's population is approximately 20,500. Bonney Lake is organized as a non-charter code city, under the mayor-council form of government and is led by a publicly elected Mayor and a seven-member City Council. Allan Yorke Park - (Lake Tapps) 7203 West Tapps Hwy Located on the south end of Lake Tapps with ball fields, covered picnic area, restrooms, boat launch, swimming area, playground, skateboard park, and tennis courts.

Boat Launch: Residents inside the city limits can purchase an annual boat launch parking pass for \$30+tax. Boat trailer parking for vehicles not displaying a valid Resident Pass is available for \$17+tax per day.



Cedarview Park - 9301 208th Ave E Multi-purpose field, large covered picnic area (available to rent), playground, tricycle path, and basketball court.

Ken Simmons Park - 18025 74th St E Located on Lake Bonney, this park has a small playground and small picnic shelters in a natural setting.

Madrona Park - 7730 182nd Ave E This is a small walk-in 'pocket' park; no parking available.

Midtown Park - 20901 SR 410 E (WSU Forest) The City acquired this 40-acre property in 2010, which includes trails and undeveloped natural areas.

Victor Falls Park This park offers a view of the 70-foot high Victor Falls waterfall, and includes trails, viewpoint, and parking area.

Viking Park - (Bonney Lake Elementary) 18902 82nd St E. Nature trail, picnic benches and dog park.

Pierce County-Lake Tapps Park - 2022 198th Ave E Operated by Pierce County and located at the north end of Lake Tapps with swimming and boat launch area.

BONNEY LAKE SENIOR CENTER

The Bonney Lake Senior Center is located at 19304 Bonney Lake Blvd and is open for drop-in services Monday through Friday, with special activities and events scheduled each month. Lunch is served daily for a suggested donation, and van transportation is available. For more information call 253-863-7658.

ANIMAL LICENSING

City residents may obtain animal licensing from the Finance Department / Utility desk at the Justice & Municipal Center. Provide proof of spaying or neutering for a reduced licensing fee. All pets must be confined to premises of the owner or restrained by a leash or other device under the physical control of a person. PERMIT CENTER

The Permit Center (Public Services Department) is located at the Justice & Municipal Center, Suite 300. A building permit is required for structures with a floor area of 120 sq ft or more, and for installation of a wood stove. For wood stoves in a mobile home, call WA L&I at 253-596-3800. Pierce County residents, call Pierce County at 253-798-7148. Addresses, parcel information, and maps for city lots are available on the City website and from Pierce County at www.co.pierce.wa.us.

BUSINESS LICENSES

Businesses are required to obtain a Bonney Lake business license if they have an office, PO BOX, or place of business located within City limits, as well as liquidators. There are exemptions for non-profits, paper carriers, and others as outlined in BLMC 5.08.050. Apply online at business.wa.gov/BLS. Call 253-447-4354 for information.

SECURITY ALARM PERMITS

Every security alarm user inside city limits must obtain an alarm permit at the Utility Department, Justice & Municipal Center, 9002 Main Street East, Suite 250. Alarm permits are valid for one (1) year, and must be renewed annually. Registration and renewal fees for residential/commercial alarms is \$24 annually, or a Senior (65 or older) or Disabled discount rate of \$12 annually. There is a \$100 per false burglary alarm, and \$200 per false robbery-panic alarm fee per BLMC Chapter 8.48. The Alarm Program Application may also be found online @ www.ci.bonney-lake.wa.us.
