I. CALL TO ORDER – Mayor Neil Johnson, Jr. called the Meeting to order at 6:00 p.m.

Mayor Johnson described his participation at the Heart of the Panther Awards and the Walmart Academy program. He acknowledged Walmart as a great community partner and noted they presented donation checks for \$1,000 each to the City's special events program and the Senior Center, as well as another \$1,500 to the Lion's Club programs.
