**I. CALL TO ORDER** – Mayor Neil Johnson, Jr. called the Meeting to order at 6:00 p.m.

Staff members in attendance were City Administrator Don Morrison, Public Services Director John Vodopich, Administrative Services Director/City Clerk Harwood Edvalson, Chief Financial Officer Cherie Gibson, Police Chief Dana Powers and City Attorney Kathleen Haggard. Various members of the Police Department were also in attendance.

**B. Citizen Comments:**

Mike Connor, 4923 Parker Rd., Sumner, WA, spoke representing the Veterans of Foreign Wars Post 3070. He said this VFW Post serves both Sumner and Bonney Lake. He invited Councilmembers and audience to join the Veterans in the 75<sup>th</sup> observance of Memorial Day on May 28<sup>th</sup>. He said services will begin at 10:00 a.m. with a lunch to follow at the Post Hall, located at 1705 Willow Street in Sumner.

Joanne Flynn, Bonney Lake Homeless Project, spoke as a representative of the group meeting to address the homeless issue in the community. She encouraged the support of the City Council in this effort to avoid becoming like Seattle.

Mayor Johnson said the City wants to be involved, and he has directed the City's administration and Police Department to stay engaged to help find a solution. Deputy Mayor McKibbin noted that the Council Safety Committee has added the topic as a standing issue for discussion at their future meetings.

He said the Committee received a Personnel Update, discussed the proposed DM Disposal rate increase, considered and forwarded for Council action the employment agreement with John Vodopich as City Administrator, approved meeting notes from the prior meeting, and discussed further concepts for the budget planning retreat.

Community Development Committee: Committee Chair Councilmember Swatman said the Committee met on May 1st at 4:30 p.m. He said they discussed a lengthy agenda forwarding seven items to this evening's Council consent agenda. He said the Committee also discussed sewer hookup requirements and the sewer comprehensive plan status and project implementation for Cedarview/Fir View and Cedar Grove sewer plans. He said the next meeting will be May 15<sup>th</sup> at 4:30 p.m.

C. Public Safety Committee: Committee Chair Councilmember Justin Evans reported the Committee met at 3:30 p.m. this afternoon. He said they had reports from the Police Department and the Fire District. He noted the district recently graduated 8 fire fighters from the Fire Academy and are looking to hire an additional nine fire fighters later in the year. He noted that two of the Councilmembers recently completed the Police Citizens Academy, and noted the addition to their next agenda to discuss the homeless issue. He said their next meeting will be on June 12<sup>th</sup> at 3:30 p.m.
