I. CALL TO ORDER – Mayor Neil Johnson, Jr. called the Meeting to order at 6:00 p.m.

- A. Flag Salute: Mayor Johnson led the audience in the Pledge of Allegiance.

In addition to Mayor Johnson, elected officials attending were Deputy Mayor Randy McKibbin, Councilmember Terry Carter, Councilmember Justin Evans, Councilmember Dan Swatman, and Councilmember Tom Watson. Councilmember James Rackley and Councilmember Michelle Surdez were absent.

Councilmember Swatman moved to excuse the absence of Councilmembers James Rackley and Michelle Surdez. Councilmember Watson seconded the motion.

Motion approved 5 – 0.

III. COUNCIL COMMITTEE REPORTS:

- A. Finance Committee: Committee Chair Deputy Mayor McKibbin reported the Committee met at 5:00 p.m., received a Personnel Update from HR Manager

Jenna Richardson and reviewed and forwarded for action a grant agreement for records management as presented by Administrative Services Director Woody Edvalson.

- B. Community Development Committee: Committee Chair Councilmember Swatman said the Committee met earlier in the afternoon and forwarded items to this evening's Council Agenda.

Public Safety Committee: Committee Chair Councilmember Justin Evans reported the Committee met earlier this afternoon and received a report on a proposed bond issue for the Fire District, discussed video arraignment for the municipal court; discussed the missing/found youth case from earlier in the month, the placement of buoys on Lake Tapps, glass enclosures for the court staff, and a program called "Keep Your Change" which reminds people not to give spare change to panhandlers, but instead to donate to organizations who can more effectively use their resources to assist the homeless.

- A. **AB18-44 – Ordinance D18-44** – An Ordinance Of The City Of Bonney Lake, Washington, Repealing Chapter 3.68 Of The Bonney Lake Municipal Code Entitled Planning Department Services And Fees, Section 15.07.072 And 15.04.080 Of The Bonney Lake Municipal Code Related To Building Permit Fees And Re-Codifying Chapter 3.68 Of The Bonney Lake Municipal Code As Building, Civil, And Planning Fees.

**Councilmember Watson moved to approve Ordinance D18-44.
Councilmember Evans seconded the motion.**

**Motion approved 4 – 1.
Councilmember Swatman voted no.**

- B. **AB18-62 – Resolution 2664** – A Resolution Of The City Council Of The City Of Bonney Lake, Pierce County, Washington, Authorizing The Mayor To Sign A Contract With Parametrix To Design The 95th Street To Angeline Road Trail.

**Councilmember Watson moved to approve Resolution 2664.
Councilmember Evans seconded the motion.**

Motion approved 5 – 0.

- C. **AB18-69 – Resolution 2670** – A Resolution Of The City Council Of The City Of Bonney Lake, Pierce County, Washington, Approving D.M. Disposal Company's Requested Rate Increase For Collection Of Recyclable Materials.

Councilmember Watson moved to approve Resolution 2670. Councilmember Evans seconded the motion.

Councilmember Watson said he doesn't agree with the amount of the rate increase believing that D.M. Disposal should have given more public notice of the issues and approached the City earlier potentially allowing for a smaller increase. He said he would be voting no on approval of the resolution. Councilmember Swatman said he appreciates the service of D.M. Disposal but can't justify an increase in city rates when next door neighbors outside the city limits are paying less. He added that he will also be voting no.

Motion approved 3 – 2.
Councilmembers Swatman and Watson voted no.

- D. **AB18-64 – Motion** – A Motion Of The City Council Of The City Of Bonney Lake, Pierce County, Washington, Appointing Three City Officials As Voting Delegates To Represent The City Of Bonney Lake At The 2018 Association Of Washington Cities Annual Conference Business Meeting To Be Held In Yakima, Washington.

Councilmember Watson moved to accept nominations for voting delegates. Councilmember Evans seconded the motion.


After Council discussion, Deputy Mayor McKibbin nominated Councilmembers Carter, Swatman and Watson as the voting delegates.
