Notice is hereby given that sealed bids will be received by the City Clerk at the City of Bonney Lake, 9002 Main Street E., Suite 125, Bonney Lake, Washington 98391, by 10:00 a.m. on Wednesday, September 9, 2020, for the **Phase 7 – SCADA System Upgrades Project**.

Work to be performed includes:

The City of Bonney Lake is requesting bids from qualified contractors for electrical and control system installation services. The Work consists of the fabrication of four lift station telemetry panels. This project also consists of the replacement of existing telemetry equipment at the City’s Lift Station No. 9, Lift Station No. 10, Lift Station No. 11, and Lift Station No. 22.

Bid proposals will be received by the City Clerk at the City of Bonney Lake, 9002 Main Street E., Suite 125, Bonney Lake, Washington 98391 by Wednesday, September 9, 2020, at 10:00 am. The bids will be tabulated by City staff and posted to the City’s website and provided to every bidder via E-mail. No public bid opening will occur due to the COVID restrictions in place by the City. The Contractors shall clearly identify project name on all submitted bid packages. Proposals received after the time fixed for opening will not be considered.
